Introduction to Social Work Research - 2025 Winter Term 1 (September 2025 to December 2025) Lecture: 3 hours per week delivered in-person Date/Time: Fridays, 10:00am-1:00pm

COURSE DESCRIPTION

SOWK 442 covers the statutory bases and practices associated with the continuum of child welfare services from prevention through permanency planning.

The Sessional Lecturer or Adjunct Professor will be responsible for teaching, holding regular office hours, marking assignments and exams and reporting grades.

QUALIFICATIONS

For appointment as an Adjunct Professor:

Instructor requirements: M.S.W. or Ph.D. in social work, who are primarily engaged in social work practice or have experience in practice related to social work policy practice and teaching at the university level.

For appointment as a Sessional Lecturer:

Instructor requirements: M.S.W. or Ph.D. candidacy in social work who have experience in practice related to social work policy practice and teaching at the university level.

Sessional Lecturer's salary: Based on the Sessional Lecturer's salary scale as per the UBCFA Collective Agreement.

Adjunct Professor Remuneration: Remuneration is commensurate with experience.

Appointment as an Adjunct Professor does not imply that the appointee has the qualifications necessary for appointment to one of the regular academic ranks.

This position is subject to availability of funds and for Sessional Lecturers will be governed by UBC's "Agreement on Conditions of Appointment for Sessional Faculty Members". Policy AP4 - Faculty Term Appointments applies to Adjunct Professor appointments.
