The School of Social Work (UBC-Vancouver) invites applications for a part-time Sessional Lecturer/Adjunct Professor to teach the following Social Work course:

SOWK 525.001 (3 credit course)

Advanced Social Work Practice: Mental Health - 2025 Winter Term 2 (January 2025 to April 2025) Lecture: 3 hours per week delivered in-person Date/Time: Wednesdays, 10:00am-1:00pm

COURSE DESCRIPTION

This course builds on students' foundational social work knowledge and skills and seeks to develop advanced competencies in the provision of mental health services. Course content includes discussions on biomedical and recovery models; engagement and relationship building; assessment and diagnosis; and treatment-related strategies. The emphasis of this course is the enhancement of students' perceptions, experiences, attitudes, knowledge and skills in clinical social work through extensive case discussions, exploration of some current best practices, and critical analysis of actual issues and concerns that the students face. As such, this course uses participatory, dialogic, and transformative processes to ensure the relevance of content and process to students' realities and replicates the Page 3 of 13 philosophy and approaches to the provision of mental health services advanced by this course.

The Sessional Lecturer or Adjunct Professor will be responsible for teaching, holding regular office hours, marking assignments and exams and reporting grades.

QUALIFICATIONS

For appointment as an Adjunct Professor:

Instructor requirements: M.S.W. or Ph.D. in social work, who are primarily engaged in social work practice or have experience related to social work practice and teaching at the university level.

For appointment as a Sessional Lecturer:

Instructor requirements: M.S.W. or Ph.D. candidacy in social work who have experience related to social work practice and teaching at the university level.

Sessional Lecturer's salary: Based on the Sessional Lecturer's salary scale as per the UBCFA Collective Agreement.

Adjunct Professor Remuneration: Remuneration is commensurate with experience.

Appointment as an Adjunct Professor does not imply that the appointee has the qualifications necessary for appointment to one of the regular academic ranks.

This position is subject to availability of funds and for Sessional Lecturers will be governed by UBC's "Agreement on Conditions of Appointment for Sessional Faculty Members". Policy AP4 - Faculty Term Appointments applies to Adjunct Professor appointments.
